Drug Treatment and Recovery Initiatives

- At outset of what became the “opioid crisis,” sharply shifted District Attorney’s Office policy to focus on prioritization of treatment and recovery engagement for defendants with Substance-Use Disorder, in partnership with Gaudenzia Addiction Treatment and Recovers Centers (2013 to 2023)
- Through a funding partnership with the Pennsylvania District Attorney's Association and Capital Blue Cross, equipped all Franklin County law enforcement officers with Naloxone, and mandated that it be carried while on duty (2016)
- Chair of the Franklin County Overdose Task Force (2016 to 2023)
- Developed and implemented the “Get Back Up” pre-charge diversion initiative, originating the role of an ex-offender Recovery Liaison who coordinates drug/alcohol assessments and subsequent care with treatment centers across Pennsylvania
- Principal proponent and developer of Good Wolf Treatment Court, the first specialty court in Franklin County (2016)
- Co-founder of Noah’s House Recovery Homes, the first “sober living” residence in Franklin County (2017)
- Installed MEDReturn boxes to allow citizens to dispose of unused and expired prescription and over-the-counter medications (as well as “sharps”), safely and anonymously (2014)
- Trailblazing partner with the University of Pittsburgh-Program Evaluation and Research Unit (PITT/PERU), which greatly assisted in gathering and analyzing local data, developing multiple strategic plans, and assisting with grant identification and applications

Principal developer, co-founder, and Board President of Over the Rainbow - Franklin County Children's Advocacy Center, seeking to restore hope and provide healing from child abuse to child victims of physical abuse and sexual assault (2014 to 2023)

- Provides a safe, child-friendly place for children and their families to minimize additional trauma that can be experienced during a child abuse investigation

- Enhanced the grading and penalties for child victims less than 2 years of age

- Worked with the Pennsylvania General Assembly and Pennsylvania Governor's Office to sign the bill (June 29, 2017)
- The law was amended in honor of Heath Ryder, a 10-month-old infant who tragically died at the hands of a juvenile while under the criminally-negligent care of a babysitter

Partnered with Kindly Canines to bring Therapy Dogs into the District Attorney's Office(s) and Over the Rainbow – Franklin County Children's Advocacy Center, in order to lessen court-related stress for victim/witness preparation and interviews, and included personal household pet Bella, who was trained and certified as a therapy dog to assist with crime victims and Good Wolf Treatment Court participants
